The parties to the above agreement IFB 004-18 agree to reinstate the Notice of Award, made by the Board of Education of Prince George's County (the "Board") and **A.H Hatcher, Inc.** for the Purchase of Services (the "Agreement") dated October 17, 2017.

2. The contract shall remain unaffected and shall continue in full force and effect in accordance with the terms set forth in the original agreement.
3. The pricing for the extension period shall **not exceed each unit price as listed (Attachment A).**

The Board will not be held to purchase any particular Brand, in any groups, prices or discount ranges, but reserves the right to purchase any item/items listed in the price schedule submitted.
