2. Is an estimated budget available?

Answer: PGCPS currently has a budget of \$1.1M allotted for SBHC’s. However, the State of Maryland may provide some additional funding once the SBHC programs and sites are approved through them. The expectation is the vendors will be able to bill Medicaid and commercial insurances.

3. Is there a start and completion date available at this time?

Answer: The goal is to have the SBHC’s functional by January 2024

4. What is the allocated budget for: Infrastructure, Clinician oversight, and Nursing support staff?
